Aim of the course

Aim of the course:

The purpose of the course is to provide a general philosophy and ethical guidance to cover all situations encountered by professional psychologists. The evolution of moral behaviours, history of professional psychologists' ethical codes, fundamental ethical principles of psychologists, relationship between legal and ethical issues, and evaluative procedures and corrective actions in case of complaints about unethical conduct will be covered by lectures, problems and dilemmas emerging in the practical application of professional ethics will be discussed in seminars.

- knows the most important expressions and phenomena of psychological ethics and the fundamental texts and contexts of the European, American and his/her national code of ethics
- familiar with the legal regulations of psychological conduct

- is sensitive to and interested in noticing ethical phenomena and problems;
- has effective communication and problem solving skills;
- his/her behavior in human relationships is ethical and humane;

skills:

- is able to identify and resolve ethical dilemmas
- is able to see causal relationships, can think logically, and can prepare comprehensive reviews;
- can perceive human behavior distinctly and can recognize situations efficiently;
- is aware of the limits of his/her competence: can differentiate between tasks that are within and outside of his/her professional competence, and does not exceed this limit;

- Ethical principles and problems of psychological research and publication.
- Competence, confidentiality, assessment, relational issues
- Ethical thinking and decision making regarding ethical dilemmas
